Liability under this Guaranty shall not be released or terminated by Conflow's failure to exercise due diligence in enforcing its rights against Applicant or against the undersigned. This is an absolute continuing Guaranty. **PAST DUE ACCOUNTS:** 

Any action to collect past due balances or to enforce the Personal Guaranty may be filed in a court of choice by Conflow.
